

**MACHINE TRANSLATION****ANNEX****CALL TO SELECT EXTERNAL DANCERS THROUGH AN EXTERNAL AUDITION TO BE PART OF THE "IT DANSA" PROJECT OF THE INSTITUT DEL TEATRE FOR THE ACADEMIC YEAR 2026-2027****1. OBJECT**

The purpose of this call is to regulate the conditions for selecting external dancers to be part of the IT Dansa project of the Institut del Teatre.

IT Dansa is a project created by agreement of the Governing Board of the Institut del Teatre de la Diputació de Barcelona, in an ordinary session dated November 19, 1996.

The objective of the Course is the technical and artistic excellence of the dancers. Currently, the artistic direction of IT Dansa is in charge of Catherine Allard, trained as a dancer at the Nederlands Dans Theater and at the National Dance Company.

The main mission of IT Dansa is to provide dance graduates with two-year professional practice opportunities – the time that the training process lasts, extendable to 3 years – with choreographies by outstanding artists and with a program of performances in the national and international theater circuit.

IT Dansa is made up of:

- 16 places for principal dancers.
- 2 places for trainees who come from the Institut del Teatre.

The total number of dancers will be subject to the vacancies that may occur in the Company after the viewing and internal audition of the students of the Professional Dance Conservatory and the students of the Higher Dance Conservatory of the Institut del Teatre, in accordance with the regulatory bases of the IT Dansa Postgraduate Degree published in the BOPB (BOPB 15/12/17).).

**2. REQUIREMENTS OF THE INTERESTED PARTIES**

To be admitted to the external audition, candidates from national and international scope must meet the following requirements:

- Have an academic background in dance. All applicants must demonstrate a solid foundation of classical dance and knowledge of contemporary dance.
- Applicants must be a minimum of 17 years old and a maximum of 23 years old at the time of application. However, only those applicants who reach the age of majority by 1st September 2026 at the latest, may be selected for the 2026-2027 academic year.

**3. PHASE 1: SELECTION PROCEDURE PRIOR TO THE FACE-TO-FACE AUDITION**

The call for this audition will be published in the Official Gazette of the Province of Barcelona (BOPB) and on the website of the Institut del Teatre within the route:

Among all this information, there will be a link to the section of the Electronic Office of the Institut del Teatre, through which participation in this call must be processed, having to carry out the following procedures **(Any doubts about the mechanism and procedure for submitting applications through the electronic office, can be resolved by writing to: [impulsa@institutdelteatre.cat](mailto:impulsa@institutdelteatre.cat)):**

Fill out the application through the Electronic Office of the Institut del Teatre by filling in the standardised electronic form that will be electronically signed with the personal digital certificate (IdCat, DNle, etc.). Filling out and submitting the application implies the commitment that they meet the required conditions and that the entire content of this call is accepted.

This standardized electronic form must be accompanied by a **COMPRESSED FILE IN ZIP FORMAT CALLED "DOCUAUDICIOITD26" which must contain IN PDF FORMAT the administrative documentation that is stated below:**

- a. Copy of the identification document (front of the DNI, NIE or Passport).
- b. Curriculum Vitae. The curriculum must contain recent photographs.
- c. A full-body photograph and a portrait photograph. Photos must be a maximum size of 1GB.
- d. The academic qualification of the dance training or equivalent accrediting document of their dance training.
- e. A document with the title "Presentation + Surname + First Name + the last four digits of the personal identification document" which contains a private link(s) to a video(s) hosted on any cloud storage service. This video(s) must have the following structure **(if access to the video requires a password, do not forget to state it in the document):**
  - e.1. Self-presentation of the candidate who will explain:
    - What motivation do you have to come to IT Dansa? (with a maximum duration of 30 seconds)
    - What qualities of yours do you consider suitable to enter IT Dansa? (with a maximum duration of 30 seconds)
  - e.2. Centre exercises (classical dance): 1 adagio, 1 of small jumps, 1 of turns and 1 grand allegro. Send only 1 piece of each exercise.
  - e.3. Extract of repertoire (fragment of a solo repertoire for boys / girls of I IT Dansa proposed by IT Dansa). The fragment can be found under the heading "Audiovisual materials for the repertoire extract" on the website of the Institut del Teatre within the route: <https://institutdelteatre.cat/itimpulsa/graduatsgraduades/inserciolaboral/itdansa/audicio.htm>
  - e.4. Improvisation (1' without cuts): take into account the use of the entire space, the changes in dynamics and qualities of movement, the different levels. This improvisation may be presented with or without music. In case of using music, it will be necessary to have the corresponding rights or use royalty-free music. The Institut del Teatre is exempt from any liability in the event that the applicant does not comply with these obligations.

The audiovisual materials generated for the presentations can be made in Catalan, Spanish, English or French.

It is necessary that in all the audiovisual materials provided the body is clearly visible (tight clothing). Videos should be clear and have the right framing plan to be viewed properly.

Characteristics of the audiovisual materials provided:

- Only links will be accepted. **Under no circumstances can the video be sent as an attachment.**
- The videos must be private and, if you have a password, the password must be stated in the corresponding document as mentioned in the previous section describing the documentation to be attached to the call.
- Video name: Videos must have the following name: "Last name + First name + last four digits of personal identification document".
- Video recording format: **horizontal**.

Interested persons who have difficulties in submitting applications electronically may submit the documentation physically or receive assistance before the deadline for submission, by going to the registry of the Institut del Teatre (Plaza Margarida Xirgu s/n) from 9 a.m. to 2 p.m. on working days, where they will receive help from the officials assigned to the Registry to carry out this procedure. All this, without prejudice to the presentation in any other electronic register of the Catalan public administrations or of the rest of the subjects referred to in article 2.1 of Law 39/2015, of 1 October, on the common administrative procedure of public administrations.

**IMPORTANT NOTE:** in order to speed up the processing of applications and ensure their reception, the Institut del Teatre is advised by sending an e-mail to [impulsa@institutdelteatre.cat](mailto:impulsa@institutdelteatre.cat) about the submission made on the same day of submission or, in any case, before the end of the deadline for submission of the application established in the call.

The submission of the application presupposes knowledge and acceptance of this call, as well as of the regulatory bases.

**Deadline for submission of documentation: from November 24 to December 12, 2025 (both included) until 2:00 p.m.**

**APPLICATIONS WILL NOT BE ACCEPTED OUTSIDE THIS PERIOD.**

**Incomplete or defective applications will be requested from the interested party for amendment, within a maximum period of 10 working days from the day following the request, which in any case will be made by email.**

**Sending the documentation and the video after the established deadline will cause the application to be rejected.**

**Very important: An electronic certificate is essential to process the application. The processing of the certificate may require a few days (even more so if you do not have Spanish nationality). It is recommended to prioritize obtaining it.**

**You can consult the different procedures to obtain the electronic certificate [by consulting this link](#). Among the different options, the procedure via the Mobile IdCat [is recommended](#) since only an official identification document (passport in case of not having Spanish nationality) and a mobile phone are necessary.**

**If, as a person with non-Spanish nationality, you have difficulty acquiring the certificate through the above procedures, you can approach the [Spanish embassy closest to](#) your place of residence to ask how to acquire it.**

#### **4. PHASE 1 ENDPOINTS**

Once the deadline for submitting applications has ended, the IT Dansa artistic team, made up of the Artistic Director, Catherine Allard, and the repeaters Mathilde van de Meerendonk and Nora Sitges-Sardà, will make the assessment in accordance with the criteria specified below.

Video-presentation:

- The motivation
- The presentation
- The technical level
- Ability to adapt to the language of the proposed repertoire

The competent body will approve the list of people admitted to the subsequent face-to-face audition that will take place at the facilities of the Institut del Teatre.

Candidates who do not receive an APTE assessment will be discarded from being able to audition in person at the Institut del Teatre. The communication of the result of PHASE 1 (list of people selected to carry out the face-to-face audition) will be published by means of the encrypted personal identification number, **during the month of February 2026 on the website of the Institut del Teatre** within the route:

The interested party will have a period of 5 working days for complaints, counting from the day following the publication.

If no complaints are submitted, the list of people selected to carry out the face-to-face audition will be considered definitive, without the need for publication.

Video evidence submitted for the hearing will be kept in custody for 1 year, for the treatment of possible claims.

#### **5. PHASE 2: CONDUCTING THE FACE-TO-FACE AUDITION**

Those who have been selected in PHASE 1 by the members of the IT Dansa artistic team will be invited to participate in the face-to-face audition that will take place on **March 28, 2026** at the [Barcelona Theater Institute. Plaza Margarida Xirgu, s/n - 08004 Barcelona](#).

At the end of each class, candidates will be informed that they are still in the audition selection process.

The selection body may require the accreditation of the identification document at any time during the audition.

## **6. ASSESSMENT OF FACE-TO-FACE HEARING**

Evaluation criteria for:

- Technical level of classical dance
- Technical level of contemporary dance

The aspects to be assessed will be:

- Body awareness
- Coordination
- Musicality
- Sense of space
- Motion Holding Capacity
- Attitude to the challenges of the class
- Artistic potential

Evaluation criteria for:

- Repertoire 1
- Repertoire 2

The aspects to be assessed will be:

- Ability to adapt to the language of the proposed repertoire
- Artistic potential
- Musicality
- Response and responsiveness to corrections given

- Motion Holding Capacity

Evaluation criteria:

- Interpretive and creative ability

Once the different available vacancies are filled with candidates who have passed the different phases of the audition, a waiting list will be created for subsequent vacancies.

## 7. AUDITION SELECTION COMMITTEE

The selecting committee of the audition will be:

- The General direction of the Institut del Teatre or person delegated by him/her.
- The artistic direction of IT Dansa or the person delegated by him/her.
- The Direction of Cultural Services or the person delegated by him/her.
- The Direction of the Professional Dance Conservatory of the Institut del Teatre, or the person delegated by him/her.

The Secretary will assume the Secretariat, with voice and without vote, a technician from Cultural Services of the Institut del Teatre or a member of the IT Dansa team who is not the artistic director.

## 8. PUBLICATION OF FINAL AUDITION RESULTS

After the external audition is held, the selection body will propose the dancers who will be part of ITDANSA Young Company.

The competent body will approve the list of external people selected to be part of ITDansa Jove Companyia and the results will be made public on the website of the Institut del Teatre within the route:

**ATTENTION. The people finally selected will be hired by the Institut del Teatre under the Social Security regime of the Spanish State and on an internship scholarship basis.**

**The contract will be managed by the Institut del Teatre before the first day of the course. In this sense, and consequently, it is very important to be in possession of the identification document (DNI or NIE) well in advance.**

**The procedures for obtaining the NIE or DNI will have to be initiated from the moment the final list of those admitted to be part of IT Dansa is confirmed. To formalise the contract, it will be necessary to present the identification document (DNI or NIE) and it will not be possible to start the IT Dansa course without having formalised the contract.**

## 12. IMAGE RIGHTS
